
4 Basic About GLTS:

The Global Law Thinkers Society (GLTS) is the multi-professionals platform for global networking and leadership. It is international organization registered in Bangladesh, Malaysia and Scotland. GLTS is WORLD RECORD HOLDER, voluntary, charitable, no-profit, non-political and social organization. It's Headquarter is in Bangladesh. It has Chapters in 130+ Countries & 30+ Categories Professionals Network.

- 1. **Executive Board** [The Board consists of founding registered members and appointed members, who has highest authority of decision and policy making]
- 2. **Power Board** [Sub-board of Executive Board to monitor, manage, research and execute all policies by made by the Executive body. This board also suggest policies to Executive Board. Power board is the lighthouse of the GLTS]
- 3. Global Advisory Board [consist of 10 Global Advisors as Honorary Position]
- 4. **Global Leaders Board** [Consists of All Global Leaders representing Countries, representing any subject as goodwill leader and continent leaders]
- 5. **Country Board** [National leaders/members/advisors and mentors will be the member of the board representing their nations/locality/subject.]
- 6. Wings Board [All wings of GLTS may form its own Executive board]

Account, Fund and Finance

- 1. GLTS Head Quarter account is in Bangladesh.
- 2. Decentral Accounts can be opened with the written authority from the HQ.
- 3. GLTS initial fund is members contribution. Donation and fees
- 4. Partnerships and CSR Funds
- 5. Public donation
- 6. Social Business etc.

GLTS Official Divisions:

Divisions are to run GLTS and coordinate with all bodies smoothly.

- 1. **Secretariat Division** [Monitor and manages secretarial work, also include LED Leaders Emergency Division to act in absence of higher authority or in emergency back up]
- 2. **HR Division** [Manages Membership, Leadership, Volunteers, Recruitment, Appointment, Assessment, database, communication and networking]
- 3. **Research, Planning and Documentation Division** [Plan, conduct and manages research, documentation, Collect programs data, publications, report writing etc.]
- 4. **IT, Creative and Social Media Management Division** [Manages all designs, IT, digital management, social media management, social media toolkits, virtual programs etc]
- 5. Legal Division [Manages all kinds of legal issues and documentations]
- 6. Event Management Division [Manages all events, PR, Media, Press, promotional matters of GLTS]
- 7. Account and Fund Division [Manages Accounts and Fund collections]
- 8. Foreign Affairs Division [Manages all foreign affairs, communications and networking]

Basic Rules and Regulations:

- 1. Executive Board is the highest board of decision making.
- 2. All members of GLTS are answerable and report to Executive board
- 3. All boards must take official permission from executive board for any activities/policies.
- 4. Executive board can take any step without answering any other board.
- 5. Executive Board members are answerable to only Executive members.

\rm Membership

✓ **Categories:** GLTS membership is divided in following Categories:

1. GLTS Member

- i) Anyone can register as a member by paying registration fee according to concern country. Members must pay membership Fees may be decided by the concern country.
- ii) Member Registered with GLTS will get a membership number and be the enlisted member of GLTS.

- iii) If any member conducts activity against GLTS regulations then the membership will be null and void immediately.
- iv) Members are not bound to work for GLTS.
- v) Members enjoy opportunities of GLTS based on contribution to GLTS.

2. GLTS Leader

- i) Any registered member hold a post in GLTS will be called GLTS Leader. Leaders must pay membership Fees may be decided by the concern country.
- ii) These leaders will be trained to work with GLTS.
- iii) If any leader conducts activity against GLTS regulations then the leadership will be null and void immediately.
- iv) There will be following types of Leaders:
 - GLTS Global Leader: From each country one male and female leader will be selected to represent their country globally.

The leaders will be selected based on -

- have registered organization/business with office. This organization/business will sign MoU with GLTS to work together as partners and address will be used as GLTS office in that country and the leader also can use all GLTS office as his own office, or
- Passionate about social work GLTS doesn't pay anything for social work so we need someone understand the value of social work.
- Networking and Leadership Capacity. We are creating network of youth in each country to change mindset of youth so they can be resilient, compassionate and proactive leader and active citizen and can bring changes in society. So that the leader can create committee/partnership/appoint province leaders etc.
 - Solvent. GLTS is a self-funded organization and have many international self funded programs, that's why GLTS needs leaders who has capability to join international self funded/partial funded program or can organize in person programs in their native country.
- Donate skills and time for the development of GLTS and use GLTS Logo and promote GLTS through activities.
- Goodwill leader: Any leader wants to represent any particular topic such as goodwill leader for peace, goodwill leader for education etc.

Continent Leaders: Represent a continent and help GLTS in building Network or recommend members to join GLTS.

> Advisors:

- i) Global Advisors: 10 members from different continents will be selected every year for forming the Global Advisors Board.
- ii) National Advisors: Each country may appoint national advisors.
- iii) Mentors: below 50 or Young advisors will be appointed as mentors

Board Members

- i) Executive members: Executive board may appoint executive board members for the progress of GLTS.
- ii) Power Board members: Executive Board and Existing Power Board members may appoint power board members for carry on all the activities of GLTS
- iii) Wing Boards: Executive Board and Power Board can appoint coordinator to form a board for any wing of GLTS
- **3. GLTS Volunteer** : GLTS volunteers are non paid members who will be enlisted with GLTS as GLTS Volunteer and may take part in GLTS programs. But if any volunteer conducts activity against GLTS regulations then the volunteer membership will be null and void immediately.
- **4. GLTS Partnership:** Any organization, institute, company group, registered/non-registered can be the partner of the GLTS. The founder/president/or selected representative have to sign MoU for partnership/collaboration based on discussion with GLTS executive-power board.
- ✓ Services Type: Services will be provided by any member is volunteer service, exchange of knowledge, skills, culture and work for betterment of the world.

✓ Opportunities for members:

- 1. GLTS promote you globally as global leader and give you award/certificates based on leadership activities.
- 2. GLTS train you and give you tasks to do that are designed to teach global leadership
- **3.** You get a multi-professional pool of international network and meet good/like minded people.
- 4. You get a chance to impact both in locally and globally
- 5. You get a chance to create your dream and get support from GLTS to fulfill that
- 6. You get international facilities as a GLTS Members
- 7. You get opportunity of financial freedom through social business
- 8. International tour and cultural exchange programs participation and many more opportunities.

✓ Cancellation of membership: Executive body has the full authority to cancel membership of any member any time. If any member is involved with or conducts activity against GLTS regulations or criminal activities then the membership will be cancelled immediately without any declaration and such membership will be null and void from the beginning of membership. And membership number will be considered as void ID.
